A. Essential qualification for the Post of Technician (T-1):

Matriculation pass or equivalent from a recognized Board.

B. Essential qualification for the post Technical Assistant (T-3):

Bachelor's Degree in Agriculture or any other branch of Science/Social Science relevant to Agriculture or equivalent qualification from a recognized University.

General Instructions to the Candidates:

- 1. Last date for receipt of applications is <u>25-01-2016</u>. However, a candidate from farflung areas of North-Eastern States, Andaman & Nicobar Islands, Lakshadweep and Jammu & Kashmir, the last date for receipt of application is <u>30-01-2016</u>.
- 2. After screening the applications, the eligible candidates, who are fulfilling the requisite qualifications, etc. will be called for written test for the above posts.
- 3. Relaxation of age shall be allowed to SC/ST/OBC/PH and any other categories as per the Rules of Govt. of India/ICAR. The relevant certificates in the prescribed form should be enclosed along with the application failing which no age relaxation will be allowed, if the candidates are applied for Technical Assistant (T-3) (unreserved).
- 4. Community certificate for SC/ST/OBC in the prescribed form from the competent authorities is to be submitted along with application. Certificates submitted in any other form or from authorities not competent to issue, the same will be ignored.

5. No age limit for ICAR employees for technical posts.

6. The posts will be governed by the New Pension Scheme introduced by Govt. of India w.e.f. 01-01-2004 mutatis-mutandis and as amended or modified from time to time.

- 7. The posts are purely temporary but likely to continue. These are transferable to any where in the country.
- 8. Applications should be submitted in the proforma appended strictly type-written/computerized accompanied by a latest passport size photograph.
- 9. Candidates are advised to send copies of all certificates (from Matriculation/10th class to higher academic and Technical educational qualification, etc., marks-sheets, caste certificate (in the prescribed proforma) and other certificates, duly attested along with their applications failing which the same cannot be considered.
- 10. Application duly completed in all respects may be sent to the Director, Directorate of Poultry Research, Rajendranagar, Hyderabad 500 030 (Telangana State) along with an application fee (non-refundable) of Rs.200/- (Rupees two hundred only) in the form of crossed D.D drawn in favour of "ICAR Unit, Directorate of Poultry Research" payable at Hyderabad on any Nationalized Bank. Candidates belonging to SC/ST category and ladies also are exempted from payment of application fee.
- 11. The envelope containing application compulsorily superscribed as "APPLICTION FOR THE POST OF TECHNICIAN (T-1)/TECHNICAL ASSISTANT (T-3)(Field/Farm) as the case may be. Applications should be sent in a separate cover for each post.
- 12. Applications received after due date under any circumstances including postal delays will not be entertained. Only hard copies received will be considered.
- 13. No correspondence will be entertained from the candidates for selection/test/appointment.
- 14. The Director, DPR, reserves the right to change or cancel the dates of written examination in the interest of this Directorate.
- 15. The above number of vacancies/posts of Technical Asst. (T-3)/Technician (T-1) may likely to be increased or decreased at the discretion of the Director of this Directorate.
- 16. No TA/DA will be paid to the candidates to appear for test. However, eligible SC/ST Candidates will be paid T.A. as per rules of Govt. of India on production of journey tickets and caste certificate.
- 17. All further instructions will appear only on the DPR website www.pdonpoultry.org/ Employment News, Hindu daily News Paper, Daily Hindi Milap, Times of India and Mana Telangana Daily News Paper (Telugu)and Andhra Jyothi Daily News Paper (Telugu).

- 19. Candidates who are in service should have to submit their application through proper channel only.

- 20. The details of the Scheme of Written Examination for the post of Technician (T-1) and Technical Assistant (T-3) (Field/Farm) have been mentioned in Annexure-I. The date of examination will be informed separately in due course of time by issuing Admit Card etc.
- 21. The selected candidates in the written examination for the above post of Technician (T-1) will have to undergo one year on-the-job training in the Laboratory, which will be provided by this Directorate. The selected candidates will be called as Technical Trainee during the training period. After successful completion of the one year training, a Certificate to this effect will be issued by this Directorate and regular appointment will be done.
- 22. The terms and conditions governing the appointment for the above post of Technical Assistant (T-3) (Field/Farm) and the terms and conditions for the Technical Trainee will be mentioned separately in the relevant order(s), which will be issued to the selected candidates in the written examination.

23. The result of the Written Examinations for the above posts shall be published according to the available vacancies on the basis of the merit and taking into account the orders for reservation for SC/ST/OBC/PH etc.as the case may be.
