MEMORANDUM

On the recommendations of the Selection Committee, the Competent Authority of this Directorate is pleased to offer the temporary post of Jr. Research Fellow to Mr. Valluri Paramesh S/o Sri V. Sathaiah at the consolidated payment of Rs.25,000/- + H.R.A. as per ICAR norms, under the DST-SERB Project entitled "Understanding the epigenetic methylation and miRNA mediated gene regulation of transcellular calcium transport genes in avian uterus during egg calcification" on the following terms and conditions:-

- The Fellowship is purely temporary for the period of 3 years or till the termination of the scheme whichever is earlier.
- His services will be extended for every six months on satisfactory performance certificate furnished by P.I. of the DST-SERB Project during the period.
- On appointment, he will draw the Fellowship at the consolidated payment of Rs.25,000/- + H.R.A. as per ICAR/DST-SERB norms. He will not be entitled for any other allowances as admissible to the regular employees of the Council.
- The Fellowship shall take effect from the date the Fellow joins the post.
- No residential accommodation and transportation will be provided.
- He will devote his whole time to the approved research programme/study under the Fellowship and will not be allowed to accept or hold another appointment paid or otherwise and will be under the administrative control of the Dr. Chandan Paswan, Principal Investigator of the DST-SERB Project.
- His headquarters will be at Hyderabad for the present but he will be liable to serve in any of the ICAR Adhoc scheme.
- The Fellow will not be permitted to resign his Fellowship during the period of the currency except with the prior permission of the Competent Authority.
- If, at any time in the opinion of the Competent Authority, Fellow is found to be negligent in his work or is guilty unbecoming conduct, his Fellowship is liable to be terminated by the Competent Authority with or without notice, as the circumstances of the case may warrant.
- Grant of leave to the Fellow will be according to the rules of the ICAR.
- If the Fellow leaves his assignment without permission of the Competent Authority, he shall not be paid any Fellowship amount due to him. He should intimate his resignation at least one month in advance to the Competent Authority to make alternative arrangement.
- He will not be entitled to (i) General Provident Fund (ii) ICAR Group Insurance Scheme (iii) All other benefits allowed to regular ICAR employees.

- His appointment will be subject to the conditions that a Civil Surgeon of Government Hospital declares his medically fit for service.
- He shall submit a declaration regarding his marital status as in the form enclosed.
- A declaration to the effect that he is not drawing any other Scholarship/Associate ship/Fellowship or in paid employment is to be made by his in the proforma enclosed.
- On appointment, he will be required to take an oath of allegiance to the Constitution of India or make a solemn affirmation to that effect as in the form enclosed.
- He should produce a character certificate from Head of the Institution last attended and a similar certificate from his present employer, if any, duly attested by a stipendiary I class Executive Magistrate (including a District Magistrate or a Sub-Divisional Magistrate).
- If any declaration given or information furnished by him proves to be false or if he is found to have willfully suppressed any material information, he will be liable for removal from Fellowship and such other necessary action as deemed fit will be taken.
- All patent rights and designs and invention derived from research work financed or aided by the Council shall belong to the Council. The Council may at its discretion allow or direct any benefit thereof to be retain by or given to the inventor.
- He is not entitled to <u>any travelling allowance</u> to join at this Directorate.
- The award of this Fellowship is subject to the rules and regulations issued by the ICAR/DST-SERB and as amended/modified from time to time.
- He has to submit an Undertaking on a non-judicial stamp paper worth Rs. 100/-for which the matter is enclosed.

In case the assignment is acceptable to Mr. Valluri Paramesh S/o Sri V. Sathaiah on the terms and conditions mentioned above, he should intimate his acceptance to the undersigned immediately and report himself for duty to the Principal Investigator of the above DST-SERB Project at this Directorate of Poultry Research, Rajendranagar, Hyderabad –500 030 on or before 20.03.2019 failing which necessary action will be taken for cancellation of the above offer.
